

## PRIVACY POLICY

In compliance with applicable data protection regulations in the United Arab Emirates, including the UAE Federal Decree-Law No. 45 of 2021 on the Protection of Personal Data (PDPL), users of this website are informed that **OZD Sports Management** fully complies with its legal obligations regarding the collection, processing, and protection of personal data.

The personal data provided by users through forms on this website will be incorporated into a secure database, of which **OZD Sports Management**, with registered office at **Active Sports Pavillion, Al Maryah Island**, and VAT number **100504943000003**, is the controller.

By submitting their personal data, users consent to its automated processing by **OZD Sports Management**, who commits to maintaining strict confidentiality and integrity of all personal data provided. Users are equally responsible for safeguarding any private access credentials associated with their accounts.

The purpose of processing such data includes: - Provision of personalized services and access to contracted services. - Statistical analysis and potential promotional communications about products and services of **OZD Sports Management** or its partners (only with prior consent).

**Users' Rights:** In line with UAE data protection laws, users have the following rights with respect to their personal data:

- **Right of Access:** Users may request information on what personal data is being processed, its source, recipients, and the purpose of processing.
- **Right to Rectification and Erasure:** Users may request that inaccurate or outdated data be corrected or deleted.
- **Right to Object:** Users can object to specific processing activities, particularly direct marketing.
- **Right to Data Portability and Restriction of Processing** as applicable by law.

Requests must be submitted to **OZD Sports Management** at **Active Sports Pavillion, Al Maryah Island** or via an official channel that enables confirmation of identity. Responses will be issued within the legally established timeframe.

**Data Accuracy:** Users are responsible for the accuracy and authenticity of the personal data they provide and must inform **OZD Sports Management** of any changes. Inaccurate or incomplete data may result in limited access to services.

**Data Sharing:** Personal data may be shared with service providers only when necessary to fulfill the purposes stated above. These providers will be contractually obligated to ensure appropriate levels of data protection.

**Security and Cookies:** **OZD Sports Management** employs appropriate technical and organizational security measures to protect personal data against loss, unauthorized access, or misuse.

This website uses cookies to enhance user experience. Cookies are small data files that allow the site to recognize the user's device and personalize content. These cookies do not contain personal identifiable information. Users may configure their browsers to disable or delete cookies at any time.
